PRIVACY POLICY

1. Introduction

Eguana Technologies Inc. and its subsidiaries, (the "Company" and "Eguana") respects concerns about privacy, and values the relationship with its' customers and external partners. This Privacy Statement describes the types of information Eguana collects, how we use that information, with whom we share it, the choices available to third parties regarding our use of the information, and how to contact us about our privacy practices.

2. Application

3. Policy Definitions

"Collected Information"

Refers to information obtained through our systems, such as our website, customer and fleet applications for ESS, Eguana-administered social media pages, or information obtained from third-party sources. When you use our systems, we may also collect certain information about your device or usage by automated means or by using technologies such as cookies and web server logs.

"Provided Information"

You may choose to provide information to us in a number of ways, such as when you request more information about our products and services, purchase a product, register a warranty, provide us with information we need for ESS commissioning (such as your name, address, postal code, utility provider), or otherwise interact on or with our systems or with our personnel through emails, chats or phone calls.

"Your Information"

Collectively, this includes both Collected Information and Provided Information. Generally, this includes your name, address, phone number(s), email address(es), product interest, product queries, system usage of Eguana products.

4. Policy Framework

Information Collected Automatically

When you visit our systems or our online advertisements, utilize our services, open an email that we send you, or interact with communication features on our systems, we may obtain Collected Information. Some of the technologies Eguana uses to collect information automatically include:

- Cookies: Cookies are small text files that websites send to your computer or other Internetconnected device, to uniquely identify your browser or to store information or settings in your browser. Some cookies exist only during a single session, and some are persistent over multiple sessions over time
- Web server logs: In conjunction with obtaining information through cookies, our web servers may log details regarding your device, operating system, or information about your usage of our systems.
- ESS telemetry: In order for your ESS to operate correctly, it must constantly measure certain electrical parameters related to your electrical grid usage and generation. We upload and store this information both to provide you with current and historical views of how your system has operated, as well as to aid us in providing troubleshooting assistance in the event of problems with your device's operation.

Use of Your Information

Eguana may use Your Information in a number of ways, including: to contact you about your request for products and services, respond to your inquiries or comments, communicate with you directly or through external social networking platforms, to conduct special events, sweepstakes or contests. SMS Consent or phone numbers are not shared for the purpose of SMS with third parties or affiliates.

We will not share your information with any third party except for the purposes of:

- Providing customer service for system repair, troubleshooting and warranty.
- To enable fleet participation with fleet operators, including utilities, which you may separately sign up with, for the purpose of identifying your system and providing its current or historical status.
